The Rusk County Appraisal District will hold a public hearing on a proposed budget for the 2026 fiscal year.

The public hearing will be held on Tuesday, June 24, 2025 at 107 North Van Buren, Henderson, Texas – 9:30 A.M.

A summary of the Appraisal District budget follows:

The total amount of the proposed budget is \$1,858,651.

The total amount of increase over the current year's budget is \$90,207.

The number of employees compensated under the proposed budget will be 11 full-time equivalent.

The number of employees compensated under the current budget is 11 full-time equivalent.

The Appraisal District is supported solely by payments from the local taxing units served by the Appraisal District.

If approved by the Appraisal District Board of Directors at the public hearing, this proposed budget will take effect automatically unless disapproved by the governing bodies of the county, school districts, cities, and towns served by the Appraisal District.

A copy of the proposed budget is available for public inspection in the office of each of those governing bodies. A copy is also available for public inspection at the Appraisal District office.
